This is the allocation that all Callan GlidePath® Target Date Funds are expected to assume approximately ten years after their designated retirement dates. The Fund is designed for investors who have retired and seek a simple method to achieve a broadly diversified investment portfolio. Investors in this Fund should be willing to accept modest movement in share price and be able to tolerate the market risk that comes from the volatility of the equity, fixed income, and real estate markets.

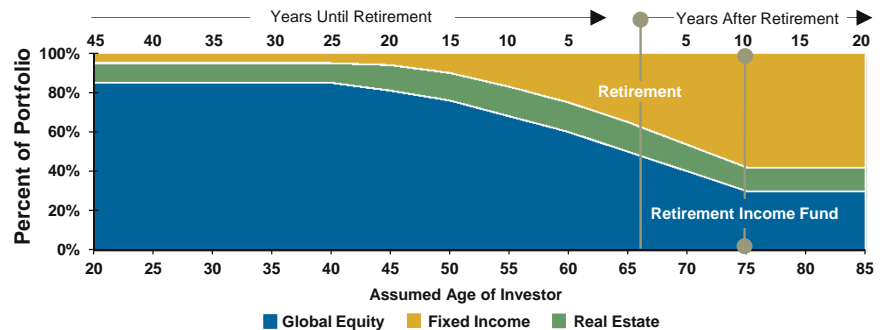

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

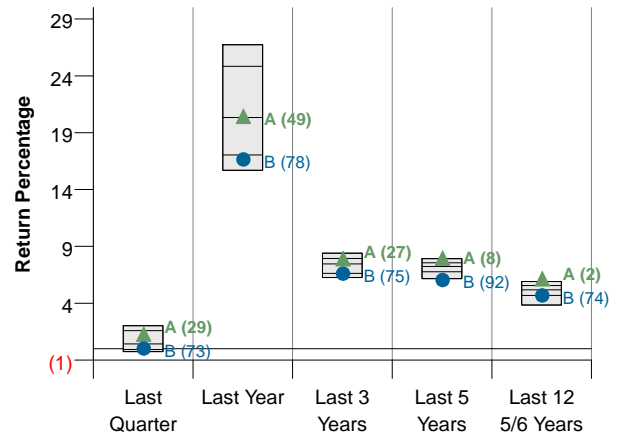

Performance Ranking (Periods Ended March 31, 2021)

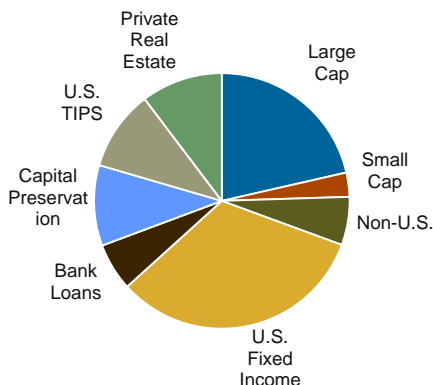

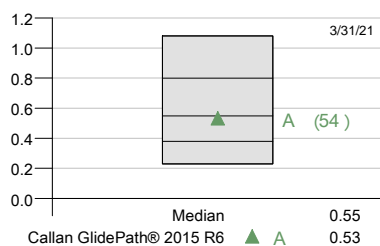

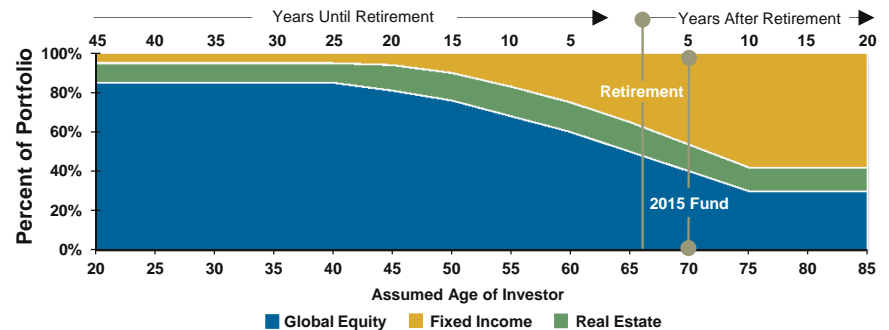

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

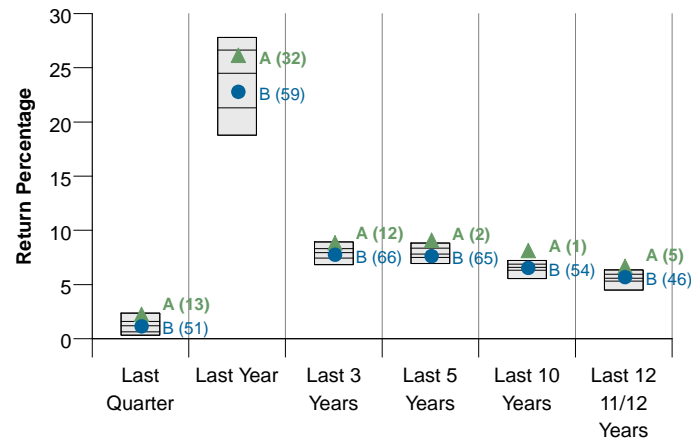

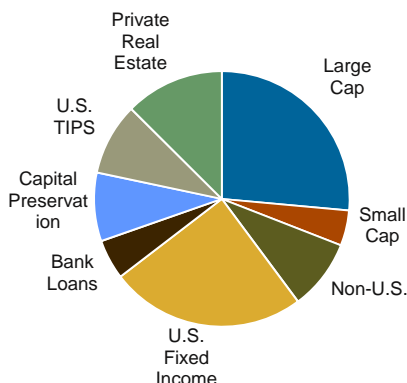

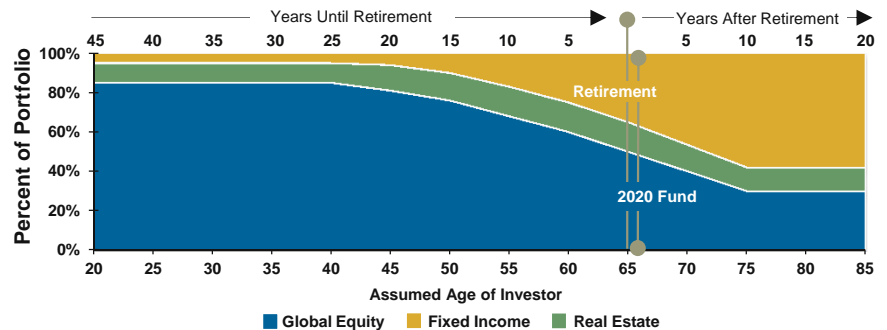

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

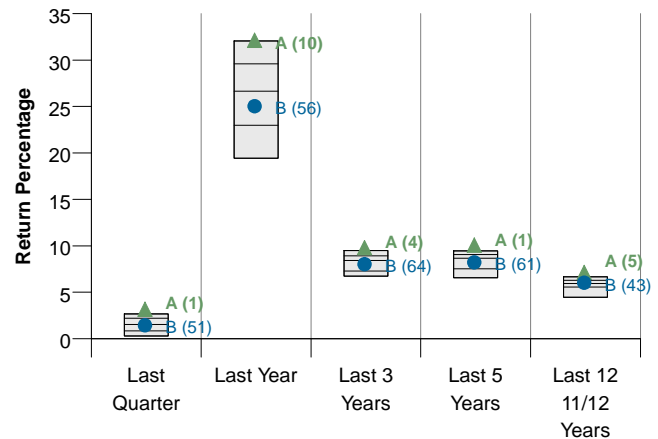

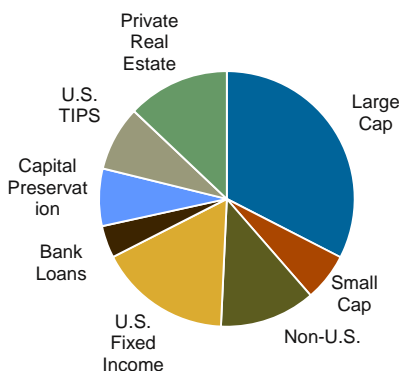

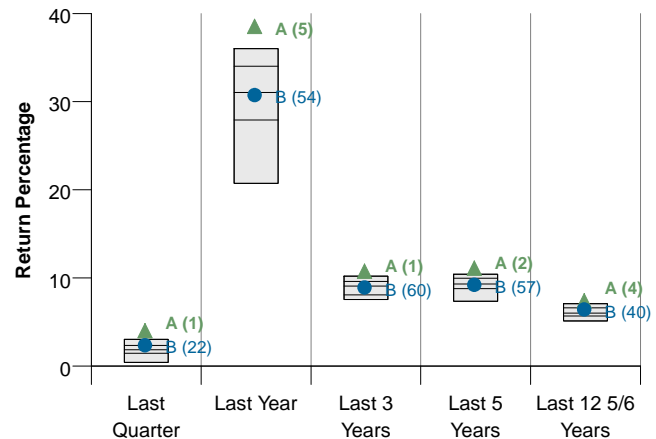

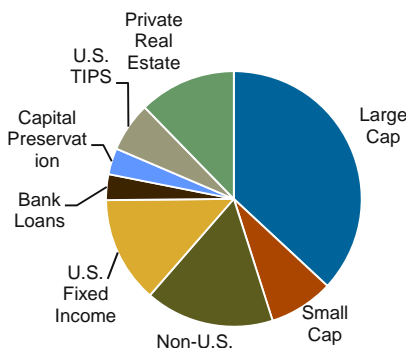

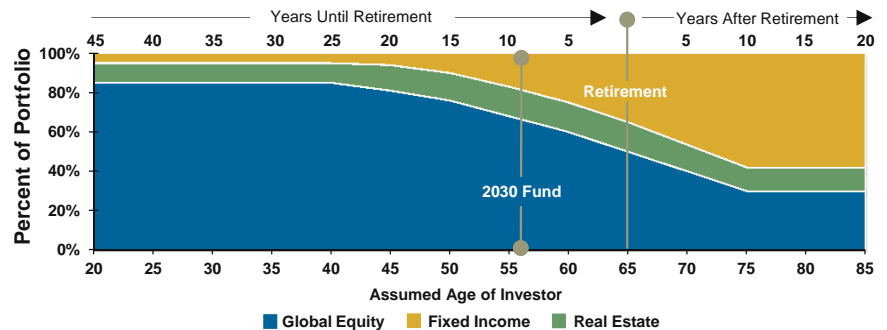

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

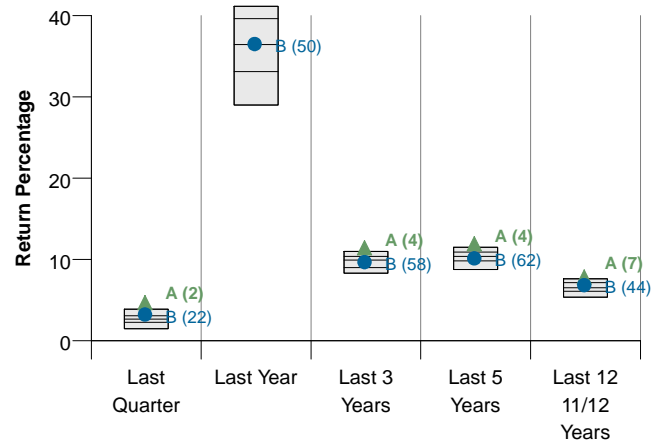

Performance Ranking (Periods Ended March 31, 2021)

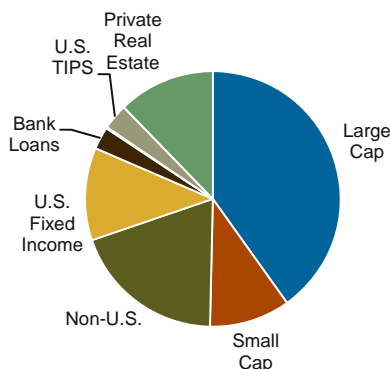

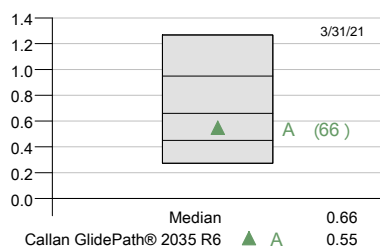

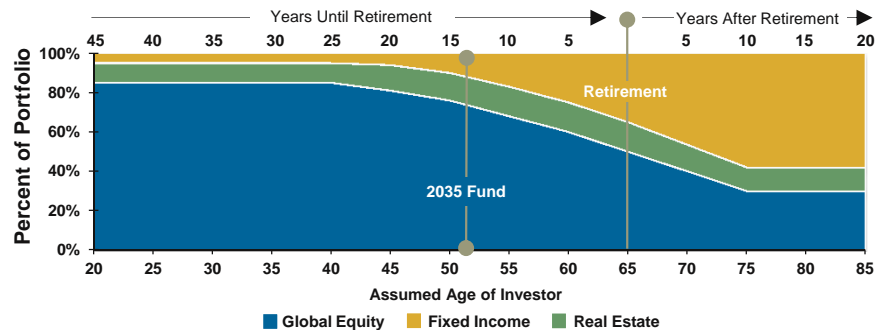

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

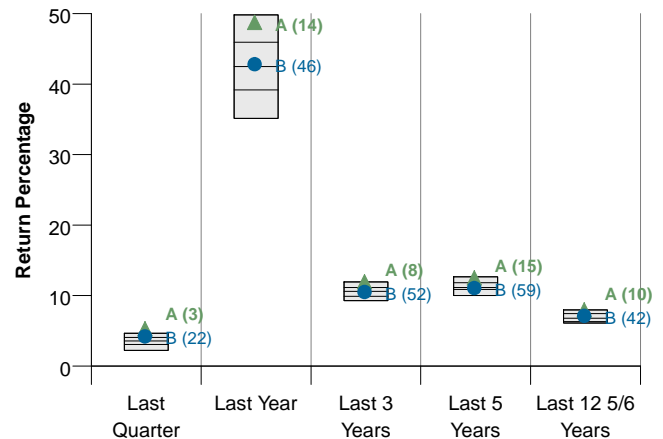

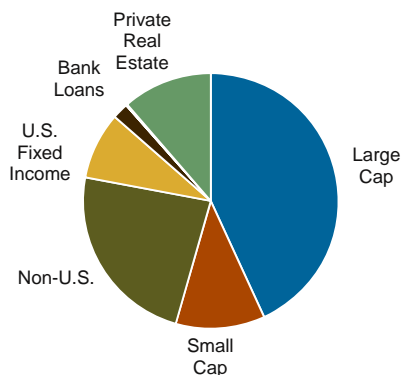

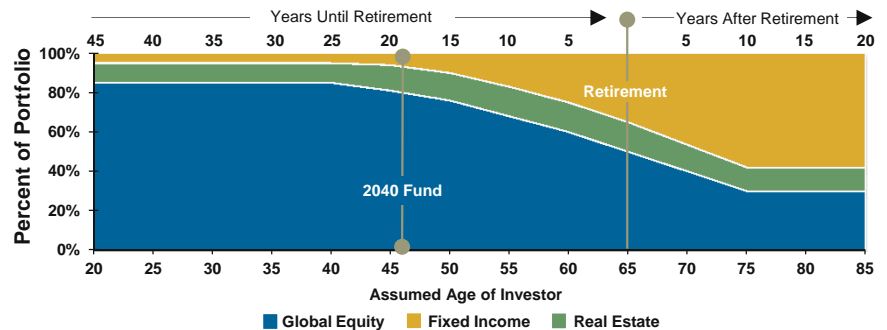

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

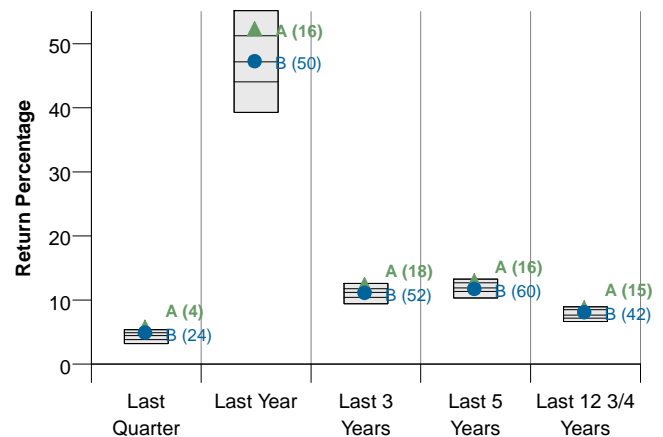

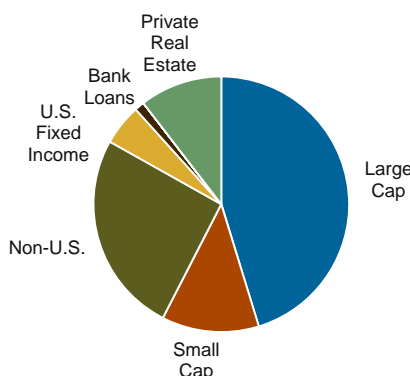

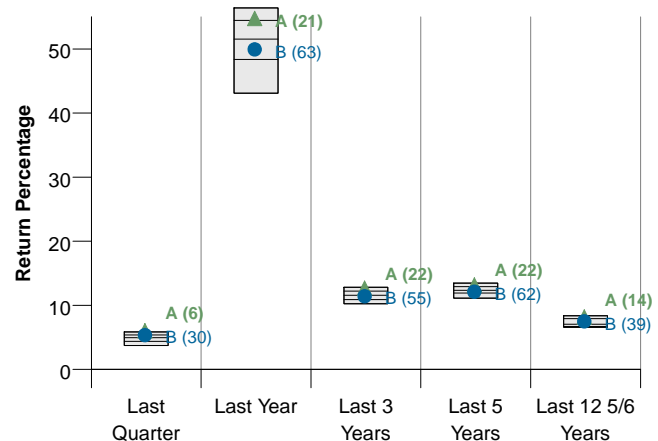

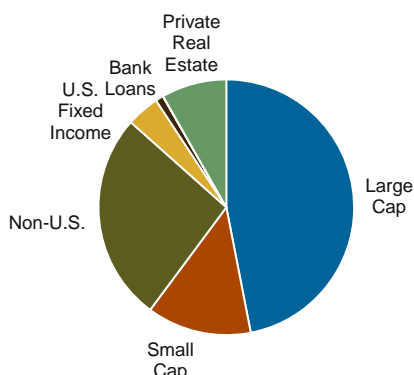

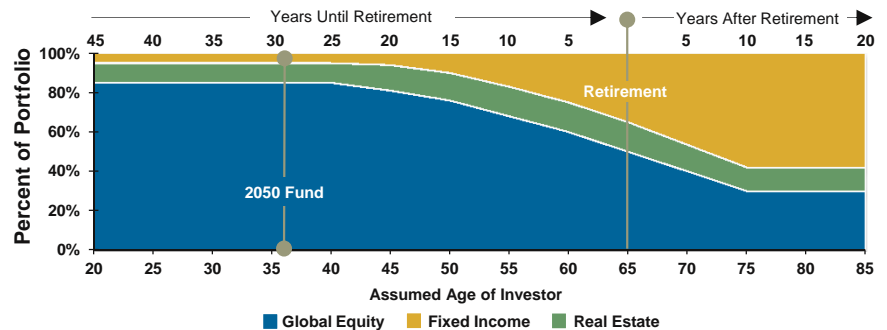

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

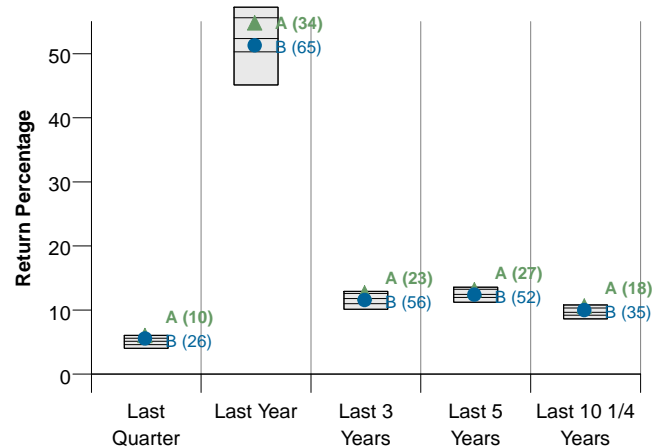

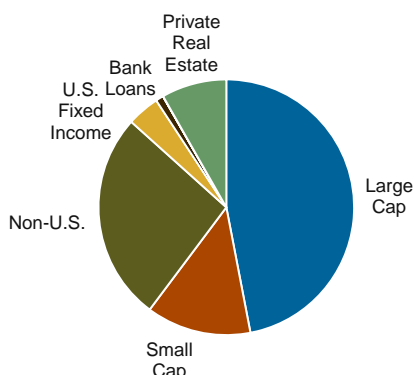

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

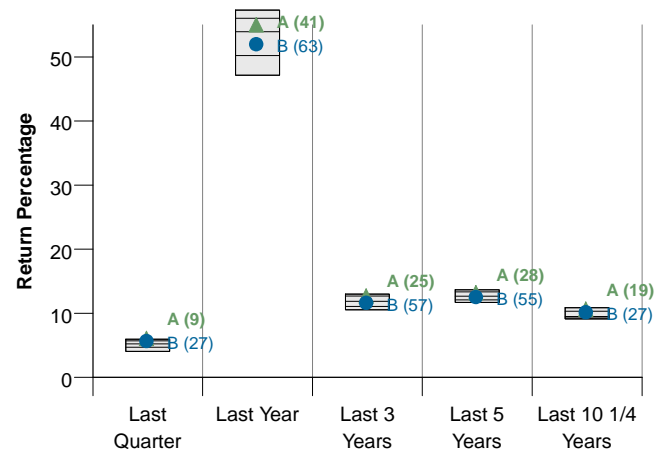

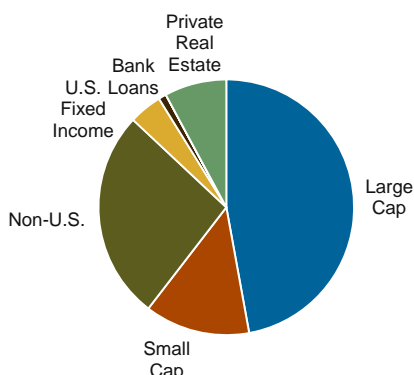

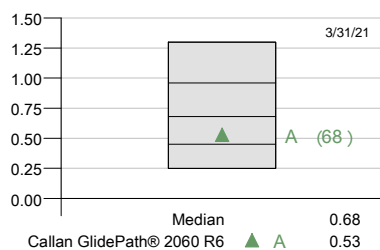

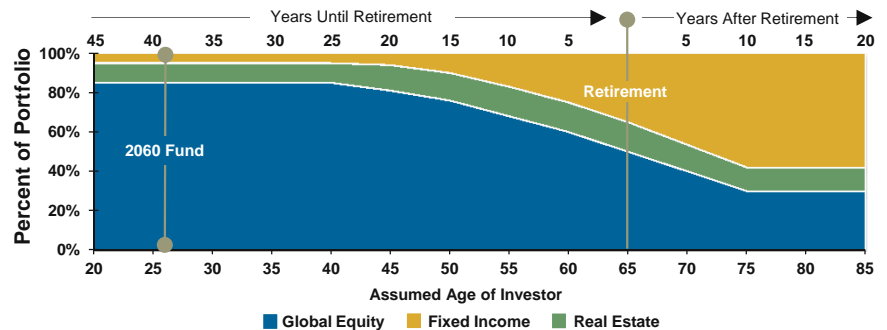

The GlidePath: Allocation of Stocks, Bonds, and Real Estate over Time

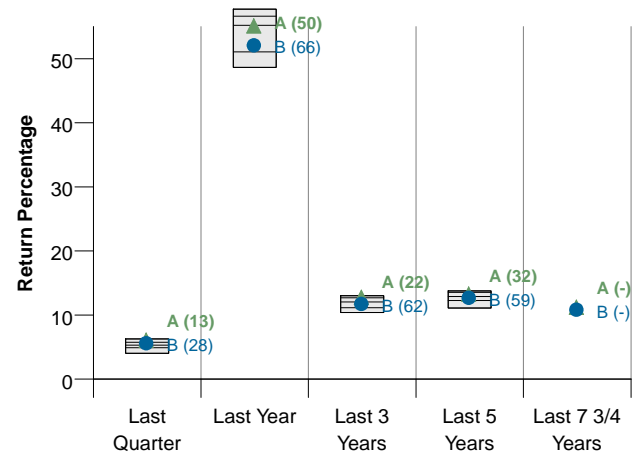

Performance Ranking (Periods Ended March 31, 2021)

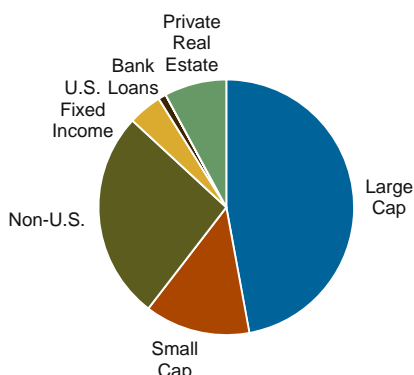
